



## PATIENT INFORMATION SHEET

### Carmine (CI 75470)

(C-059)

Your patch testing results indicate that you have a contact allergy to [Carmine \(CI 75470\)](#). It is important that you familiarize yourself with this chemical and take steps to avoid coming in contact with it.

#### What is [Carmine \(CI 75470\)](#) and where is it found?

Carmine is a natural bright red dye. It is used in cosmetics (makeup products, hair products and soaps), foods, drinks, drugs, paints and pigments. Carmine is derived from the *Dactylopius coccus* insect. The female insects are harvested and processed, yielding bright red pigment. The use of carmine is increasing because of use restrictions on the synthetic red dyes, which may be carcinogenic.

#### What else is [Carmine \(CI 75470\)](#) called?

This chemical can be identified by different names, including: Natural Red 4, Aluminum lake of carminic acid, Carminate borax, Carmine aluminum lake, FEMA No. 2242, CI 75470, EC No. 215-724-4, Cochineal extract lake, Nacarat carmine. This may not be a complete list as manufacturers introduce and delete chemicals from their product lines.

### THINGS YOU CAN DO TO HELP MANAGE YOUR CONTACT ALLERGY

**Be vigilant... read the product label.** Always take the time to read the ingredient listing on product packages. This should be your first step each time you purchase a product as manufacturers sometimes change product ingredients. If you have any concerns ask your pharmacist or your doctor.

**Test the product first.** If you have purchased a new product you should test it on a small skin area to see if you get a reaction before using the product on larger skin areas.

**Advise people you obtain services from of your contact allergy.** This should include people like your pharmacist, doctor, hairdresser, florist, veterinarian, etc.

**Inform your employer if the source of your contact allergy is work related.** You should identify the specific source of the chemical and take the necessary steps to avoid further exposure. Protective wear may be adequate or you may need to make a change in your work activities. Both you and your employer benefit when the cause of your occupational dermatitis is eliminated.

**"Google" it.** The internet is an excellent source of ingredient information that can be searched by product, by company and by specific chemical.
